EXPECTATION AGREEMENT

I understand that if I win the title of Miss Rodeo Kern County Jr Queen, Princess or Jr. Princess, (MRKC) I will be Kern County's Official representative and responsible to present the sport of rodeo in it's true **positive** light to the general public.

- I will strive to represent unexcelled sportsmanship, while exhibiting high moral and ethical character during the pageant. I have read the rules regarding sportsmanship and proper conduct during the pageant and agree to follow these rules.
- I will educate myself concerning the proper treatment of animals used in rodeos and agree to treat all animals in a humane way.
- I understand that the MRKC Pageant is not a beauty contest. Rather it is a competition that recognizes a number of attributes: Horsemanship, personality, public speaking and appearance. Therefore, it will be my responsibility, as Bakersfield's official rodeo representative to act, speak and dress according to the esteem my title deserves, any time that I am in the public eye.
- Riding and horsemanship skills are key to the promotion of the sport of rodeo. Therefore, I will strive to improve my riding and horsemanship skills so that I can better promote the sport of rodeo.

If I become MRKC, I will:

- Wear my MRKC banner, western hat, western boots, as well as suitable western attire, any time I am acting in the capacity as MRKC.
- Avail myself of all opportunities to appear as MRKC to the public and to be prepared for photographs and interview opportunities to promote the sport of rodeo.
- Attend specific rodeos as requested by the MRKC Pageant Executive Board that requests the appearance, and attend other rodeos.
- Understand and agree to execute a contract with the MRKC Pageant Inc. with respect to my duties as MRKC.
- Understand that during my reign as MRKC, the MRKC Pageant Executive Board's representative in charge of appearances must approve all of my appearances as MRKC and I agree to maintain close contact with that representative.
- Agree that during the term of my entry as a contestant and throughout my reign as MRKC, I shall remain Unmarried and without child and shall observe a high standard of moral and ethical behavior, including all internet sites, such as Twitter, Facebook, Instagram, Snapchat etc. befitting my title and setting a good example to the public, future competitors, and the MRKC Pageant.
- Not engage in the unlawful possession, use or distribution of illicit drugs or alcohol during any scheduled time or appearance, nor will I engage in any questionable behavior involving such substances during my tenure as MRKC.
- Agree to provide my own horse and transportation to all events as necessary.
- Agree to execute the accompanying Waiver Agreement.
- Agree that I have read and understand the MRKC Pageant, Inc., Rules and Regulations and will abide by these rules during the entire MRKC Pageant and during my reign as MRKC, should I earn the title.

I _____ attest that I meet the MRKC Eligibility Requirements and I understand and agree, as a contestant of the MRKC Pageant, to comply with the expectations set forth in the MRKC Pageant Contestants Expectations. I understand that if I fail to meet the aforementioned Eligibility Requirements or Contestant Expectations, I will not be eligible to hold the title “MRKC”, and will not be permitted to compete in the MRC Pageant.
